# Here's to 25 Years!




### **COMING DOWN THE PIPELINE**

### Longtime GMHCN Staff Member Sees Recovery Coming Full Circle

Gail Herrschaft is the Project Director for Double Trouble in Recovery meetings in Metro Atlanta. She is currently the longest serving staff member at GMHCN and a few weeks ago she approached The Pipeline about sharing something that she has seen in our recovery community here at the Georgia Mental Health Consumer Network.

Gail says that she was introduced to recovery 18 years ago and the organization saw something in her that she did not see in herself. She says that GMHCN has "taught me the importance of taking care of myself, mind, body and spirit" as well as about stigma and how to combat it. She is grateful for the opportunity to be herself that GMHCN has provided. It was through her work at GMHCN that she met a peer named Lindsey and sees the continued success of GMHCN through her peers.

Gail met Lindsey Sizemore in the Dekalb County Jail. She says that Lindsey "seemed different; she wanted recovery and a new way of life." Lindsey spent a total of 33 months in jail and was released to a half-way house. During this time she worked two jobs and became one of the first peers to participate in the Forensic Peer Mentoring Project through GMHCN. It was through that first introduction to GMHCN in the Dekalb

County Jail that Lindsey really started to utilize the many recovery offerings of GMHCN. After completing the Forensic Peer Mentoring Project she went on to attend and graduate from the Georgia Peer Support Institute, the RESPECT Institute of Georgia, and Certified Peer Specialist Training. In addition to her trainings through GMHCN she has also become a Certified Addiction Recovery Empowerment Specialist through The Georgia Council on Substance Abuse.

For Lindsey she ended up somewhere she says that she thought she would never be: A GMHCN staff member. Earlier this year Lindsey accepted a position with the RESPECT Institute of Georgia as an Outreach Coordinator. She continues her recovery and facilitates the recovery of others by arranging for peers (herself included) to tell their stories across the state. These stories influence policies and public perception about the recovery community and keep the ripple of hope going.

Gail says, and Lindsey agrees, that GMHCN "has become a symbol of hope for those of us who have been stigmatized by society... into thinking we will never recover." Gail has a message for peers "who have been hospitalized or even gone to jail. There is hope. GMHCN does not discriminate as they see the potential in all of us. Remember there is always hope. We can and do recover. Please go to our website www.gmhcn.org and see if you are interested in our organization and what it has to offer."

## **GMHCN Takes On San Diego**

The Georgia Mental Health Consumer Network was well represented as a large contingent of staff attended the Alternatives Conference in San Diego, CA this year. In addition to our Executive Director Sherry Jenkins Tucker other attendees included staff from the RESPECT Institute team, the Georgia Behavioral Health Planning and Advisory Committee, Recovery Foundations Trainings, the Peer Mentoring Project/Forensic Peer Mentoring Project, as well as the Peer Support, Wellness and Respite Centers.

The Alternatives Conference is a conference held annually around the country organized for/by peers through Peerlink National Technical Assistance Center via a grant from SAMHSA. This years conference, held September 19 - 23 was the 30th year that it has been held.
